


Situation:

Early 83496A shipments used CDR assembly 83496-63001 Rev 004 assemblies which required fairly extensive rework (resistor changes, IC change, via modification). 83496A specifications for the Rev 004 and Rev 005 are the SAME, but the rework on Rev 004 assemblies MAY increase the likelihood of field failure slightly.

⇒ If the Rev 004 CDR board fails within the first 2 years of shipment, the CDR assembly will be replaced with a Rev 5 (or later) assembly at no cost to the customer.

Starting with S/N US4400230, all new 83496A shipped with Rev 005 assemblies.
