- Service Note E2225-01 had some serial numbers missing.
- The CON2 flashing exception is now lifted, see SN E2225-03.

With the new Agilent has extended the CAN Bus support of CAS v.1.51 to accomodate the newer CAN Bus CCP2.1 protocol. V.1.51 supports CCP2.0, v.1.52 support CCP2.1. Minor Bug fixes are also incorporated with v.1.52. Agilent has shipped 30 units to date with v.1.51, to accounts not using the CAN functionality.

## Solution / Action:

This service note allows the conditional installation of CAS 1.52 to customers who bought 1.51 free of charge. The following conditions must apply:

- The serial number of the system main frame must be in the range listed above.

#### AND

- The customer must require support of the CAN Bus under the CCP2.1 protocol.

#### OR

- The customer has experienced known software defects corrected in V1.52. This case only under direction of and after agreement with Division 4222 Support Engineers.
